Other forms of notice are not sufficient. The effective date of the cancellation is the date we receive the written cancellation notice. A name change or substitution of participant is also treated as a cancellation in that all cancellation charges apply. Cancellation charges are per-person, based on the cancellation date, as follows: after Group Review Date and up to 121 days before departure: \$200 loss of deposit; 120-90 days before departure: \$400 loss of deposit; 89-60 days before departure: 35% of cruise and land price; 59-30 days before departure: 50% of cruise and land price; 29-7 days before departure: 80% of cruise and land price; 6 days or less before departure: 100% of cruise and land price. Deposits for A+, AA+ and Suites are non-refundable. Protection plan premiums are non-refundable. After travel begins, there is no refund for unused services, or unused portions of cruise, cruise/tour or airfare.


